## Jenni Pompi

Running for Board of Ed bc she's a parent in PGCPS and the perspective is needed. Loves living in PG County, and recognizes that as our schools grow and are successful so is our county. We need people on the board who put kids before politics. Doesn't believe that the board of ed should be a political on ramp. Wants our schools to be the best that we can.

Hoping to focus on equity/inclusion, 21st skills, outreach and engagement. CPA is a District 2 school. Share the District 2 areas.

Q: What's the remedy to the smear campaigns against PGCPS? It's unfair for ppl to attack our school district?
A: The bad news always outweighs the good news. Uplift our good stories- Climate Action plan for example. We have policies for equity and inclusion that we should be proud of. Curriculum is culturally relevant, grade level appropriate (with examples).

Attendee thanked Jenni for running; shared personal connection. Ask to advocate for policies for structured reading throughout the curriculum.

A: And giving teachers the resources to implement the policies.
Attendee discussed bilingual leadership/teachers and the need for bilingualism among staff in PGCPS. RP ES as an example.

A: Community schools such as RPES often have a liaison/coordinator. Sees some recognition of the need by PGCPS.

## New Business/Questions

What's been the biggest challenge that Leadership has seen, that can help parents support kids?

A: Over the summer looking at Edgenuity data, working with teachers around Math for students below grade level. If students don't have skills in particular areas, we have to find ways to get them caught up. On the flip, we have a lot of advanced students, finding ways to enrich and push those students. Facing the data and coming up with ideas and solutions to push our kids.

Q: Thank you for the effective communication, responsiveness. Waiting for the avalanche, when does the 6th grade HW hit?

A: If a student is doing all they need to at school, they shouldn't have a tremendous amount of homework. Reading 20-30 minutes and 30-45 minutes of HW.

Q: If Mr. Baker can collect big goals/items that teachers want. Drive the funding towards that.

Q: Field Trips? A: Yes!
Q: How are field trips funded?
A: At times PTO support. Student based budgeting has some $\$$ for transportation- trips, athletic events. Try for minimal charge.
